WHEREAS King Travel can Ltd., located at 1325 , Suite 218, mississauga Ontario L4W 4L9, its officers, director, employees, servants and volunteers, is in the business of providing Umrah services and assisting Umrah Pilgrims to perform their Umrah Pilgrimage in Saudi Arabia ("Services"); AND WHEREAS you are entering into a legally binding agreement with King Travel Can Ltd. to provide you with the Services; AND WHEREAS you confirm that you have been advised by King Travel can Ltd. and that you recognize that King Travel can Ltd. does not own, manage, Controler operate any transportation vehicle,hotel, resort, restaurant or other supplier and is not responsible for their acts or omissions; NOW THEREFORE IN CONSIDERATION of King Travel can Ltd. providing the Services, I agree as follows:

1. King Travel can Ltd. shall not be responsible for, or assume liability in connection with, any loss, damage, expense or injury, whether physical or mental, resulting from any delay, or any act, omission, negligence or commission of any party supplying any of the services or accommodations, its agents, servants, employees, subcontractors, or for any claims for such loss, damage or injury, whether physical or mental, arising there from, or from any cause that arises by reason of actions of parties other than King Travel can Ltd.. Without limiting the generality of the foregoing, King Travel can Ltd. shall not be responsible for, or assume liability in connection with, any injury, damage, death, loss, additional expenses or accidents, suffered by me, in any manner whatsoever, including as a result of defects in any vehicle, or through the acts or defaults of any company or person engaged in transporting me.
2. King Travel can Ltd. shall not be responsible or liable in connection with any losses or additional expenses occasioned by me as a result of the acts of God, delay or changes in schedules, overbooking or sickness, weather, strikes, war, quarantines, epidemics, pilferage, customs or immigration regulations or other acts or circumstances in this connection beyond King Travel can Ltd's reasonable control.
3. All or any such losses and expenses as aforementioned will be borne by me and will be my sole responsibility to the complete exclusion of King Travel can Ltd.
4. I AGREE in case of cancellation of package the total amount is non refundable.
5. I AGREE that i will not use any service which is not paid to King travel if i involve to use any service King travel have right to take legal action or i will paid that amount as per billed from Ksa.
6. I FURTHER AGREE to release and forever discharge King Travel can Ltd. from any and all actions, causes of action, claims and demands for, upon, or by reason of any damage, loss or injury, to me and my property which may be sustained in consequence of the losses and expenses as aforementioned.

I FURTHER AGREE TO INDEMNIFY and save harmless King Travel can Ltd. against and from any and all claims and demands, actions, and claims for contribution or indemnify, whether under any statute or otherwise, which may be made or brought against King Travel can Ltd., including the costs of defence of such action and claim, as any such claims or demands relate to my Umrah Pilgrimage.
8. I FURTHER AGREE that King Travel can Ltd. shall not be required to provide any refunds or adjustments for portions of the Services not utilized.
